

**RESOLUTION DESIGNATING LOCATIONS FOR  
MEETINGS AND PUBLIC HEARINGS OF THE BOARD OF DIRECTORS OF THE  
LOST PINES GROUNDWATER CONSERVATION DISTRICT**

WHEREAS, Texas Water Code Section 36.062(b) allows the Board to designate locations for meetings of the Board of Directors of the Lost Pines Groundwater Conservation District (“Board”); and

WHEREAS, Texas Water Code Section 36.403(c) allows the Board to designate locations for public hearings on applications for permits and permit amendments before the Lost Pines Groundwater Conservation District (“District”); and

WHEREAS, District Rule 2.1(B) authorizes the Board to establish the locations for meetings of the Board; and

WHEREAS, by previously adopted resolutions, the Board has designed the following locations for regular and special called Board meetings and public hearings on applications for permits and permit amendments before the District: (1) Bastrop City Hall, Bastrop, Texas; (2) Bastrop Convention Center, Bastrop, Texas; (3) Giddings American Legion, Giddings, Texas; (4) Giddings City Hall, Giddings, Texas; (5) Lexington Park Building, Lexington, Texas; (6) Elgin Public Library, Elgin, Texas; and (7) American Legion Post 533, Bastrop, Texas.

WHEREAS, the Board desires to designate additional locations for regular and special called Board meetings and public hearings on applications for permits and permit amendments in Lexington, Texas;




